Theft Loss Tax Deduction

Section 165(e) of the Internal Revenue Code allows certain fraud victims with no reasonable prospect of recovery to take immediate "theft loss" tax deduction of 95% of their losses, or 75% of their losses if they are pursuing third-party recovery. We assist fraud victims nationwide by evaluating, preparing and filing the theft loss tax deduction claim. The fraud losses are deductible as ordinary losses as opposed to capital losses. Prices start at \$2,500.

Receivership Claim Submission

A receivership is a legal mechanism used by the SEC in certain securities fraud cases to gather the assets of the fraud and distribute them to aggrieved investors. We assist fraud victims nationwide by evaluating, preparing and filing claims on the victims behalf to recovery money in SEC other fraud related receiverships. Prices start at \$1,000.
