Mr. Donell is the President of Jalmar Properties, Inc., AMO[®] a real estate investment and property management company specializing in the acquisition, development and management of commercial, retail, industrial and multi-family housing in California, Arizona and Nevada. The company was formed in 1985 and has provided management services for real estate properties with a market value in excess of \$1 billion.
